THE CHAPTER 11 TRUSTEE *NUNC PRO TUNC* AS OF SEPTEMBER 23, 2010**


This case is before the Court for consideration of the Application (the "Application") of Michael Phelan, the Chapter 11 Trustee of the consolidated Chapter 11 cases of Lydia Cladek, Inc. (the "Chapter 11 Trustee"), for an Order authorizing the retention of Prudential Network Realty ("Prudential"), *nunc pro tunc* to September 23, 2010, as real estate brokers to the Chapter 11 Trustee in the above-captioned case, and the Court having conducted a hearing on October 27, 2010, considered the Affidavit of Ann King in support of the Application, and being otherwise advised in the premises, and no objections to the Application having been filed, it is

ORDERED:

1. The Application is GRANTED on a final basis.
2. The Chapter 11 Trustee is authorized to retain Prudential as real estate brokers to the Chapter 11 Trustee in accordance with the terms set forth in the Application, *nunc pro tunc* to September 23, 2010.

3. The compensation of Prudential for professional services rendered and reimbursement for costs advanced shall be fixed by the Court upon application and notice as may be directed by this Court in accordance with 11 U.S.C. §§ 330 and 331.
