**ORDER ON THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS
AMENDED APPLICATION FOR AN ORDER AUTHORIZING THE EMPLOYMENT
OF THE ACCOUNTING FIRM OF BUTTNER HAMMOCK & COMPANY, P.A. AS
ACCOUNTANTS *NUNC PRO TUNC* TO SEPTEMBER 1, 2010**

THIS CAUSE came before the Court on November 10, 2010 upon the Official Committee of Unsecured Creditors' (the "Committee") Amended Application for an Order Authorizing the Employment of Buttner Hammock & Company, P.A. as Accountants *Nunc Pro Tunc* to September 1, 2010 (Dkt. No. 318; the "Application"). For the reasons stated orally and recorded in open court that shall constitute the decision of this Court, it is

ORDERED that:

1. The Application is hereby approved and the Committee is hereby authorized to employ Buttner Hammock & Company, P.A. (collectively, "BHC"), *Nunc Pro Tunc* to September 1, as accountants to render professional accounting services to the Committee in this case pursuant to § 328 of the Bankruptcy Code.

2. Subject to this Court's approval, BHC will charge for its accounting services on an hourly basis in accordance with its ordinary and customary hourly rates for services of this type and nature, and for this type of matter, in effect on the date such services are rendered, and for its actual, reasonable and necessary out-of-pocket disbursements incurred in connection therewith.

3. Compensation will be awarded to BHC upon application and a hearing consistent with the requirements of 11 U.S.C. §§ 330 and 331.
